<u>POLICIES AND PROCEDURES</u>

WAITLISTS

Wait lists will be taken for each class, camp and event. Charges will not be made to while a student remains on a wait list. Once a class begins and there are no withdrawals the wait list will be considered null. Students will not be added to a class from the waiting list once a class has begun.

REFUNDS

Refunds will be made if notification of cancellations is received seven (7) days or more prior to the beginning of an event if and only if the spot can be filled. A \$15 cancellations fee applies. Cancellation fees will automatically be deducted from any refund due. Art Works Studio and Classroom reserves the right to cancel an event due to insufficient registration with full refunds and notification.

<u>RELEASING CHILDREN</u>

A parent or responsible adult (listed on registration form) must sign your child out. Only the people listed as your emergency contacts will be authorized to pick up your child. If a person other than the parent is picking up the child a photo I.D. will be required to verify the adult's identification. If an unauthorized adult attempts to pick up your child or if the adult's identification cannot be verified with a picture I.D., staff WILL NOT release your child to him/her. Please remember that parents will need to show identification to the staff on the first days as the staff might not know the parent yet.

LATE FEES

The closing time of the camp is 6:00 p.m. You must pick up your child by this time. Late fees are charged starting at 6:05pm and are due when your child is picked up. You will be charged \$5.00 per child for the first 15 minutes you are late picking up your child(ren) and an additional \$1 per minute per child thereafter.

MULTIPLE FAMILY MEMBERS DISCOUNT

Two (2) or more family members enrolled in same class or camp will be given a \$100.00 discount off registration fees.

<u>RETURNED CHECK FEE</u>

Any check returned for insufficient funds must be paid for in cash and will be subject to a \$25.00 surcharge. Furthermore, you may be required to make all future payments in cash, credit card or by money order.
